I currently have the campaign account "Friends of Joshua Stonko" open with approximately \$1,000 remaining. I also have roughly \$7,000 worth of campaign signs, supplies and materials.

I am a longtime resident of Carroll County and a graduate of the University of Maryland, College Park with a degree in economics. During my career, I have helped to build a successful small interpreting business, "Signs of Dawn, Inc.". We have grown to become one of the larger independent contracting interpreting companies within the Maryland market.

I have served on Congressman Roscoe Bartlett's staff learning the most efficient ways to assist constituents with their problems created by the government. I have also served on former State Senator Joe Getty's staff working on state legislative issues and the state budget.

I currently work at PNC Bank as a business banker and ACEEL associate. My roles are wide ranging but focus on the growth and retail aspects of consumer banking.

In my 2014 primary campaign I was unsuccessful in my campaign to be elected to the Maryland House of Delegates, but I was able to mount a strong campaign without previous name identification, self-funding, or the use special interest monies. In an internal poll from January 2014, I polled within the margin of error (less than 3.5% of the vote) and within five months received 13.8% percent of the vote. During the campaign I was able to raise over \$32,000, all of which came from individual contributors. These personal donations matched or far outpaced each of the six other candidates when excluding special interest or self-funding. While being outspent by tens of thousands of special interest dollars my focus on retail politics led me to 5,813 votes and a 4th place finish in the primary.

I also worked for the Bongino campaigns and the Romney campaign in Ohio during my time as the Vice-Chairman of the Maryland College Republicans.

1. Please describe what you believe is the role of government

"We the people of the United States, in order to form a more perfect union, establish justice, insure domestic tranquility, provide for the common defense, promote the general welfare, and secure the blessings of liberty to ourselves and our posterity, do ordain and establish this Constitution for the United States of America."

More explicitly, the role of government is to protect the unalienable rights of its citizens.

2. Please explain your economic views and major economic influences

I am a strong supporter of free and open markets. I believe that the most efficient way to encourage innovation and job creation is for the government to stay out of the way and allow the laws of supply and demand to dictate market choices. When government gets more involved in the economy, natural market forces are disrupted and often lead to long-term failures in the market.

My major economic influences are F.A. Hayek, Milton Friedman, and Thomas Sowell.

3. What is your position on gun control and the Second Amendment

"A well-regulated militia, being necessary to the security of a free state, the right of the people to keep and bear arms, shall not be infringed."

I believe in the strict definition of the text in the Constitution. The Second Amendment guarantees each of us our Constitutional right to defend ourselves. Governor O'Malley and the Maryland General Assembly have taken unconstitutional measures to take away this right. It is our responsibility to respond to these restrictive actions. I believe the SB281 is unconstitutional and needs to be repealed.

4. What is your position on abortion and euthanasia

I believe that life begins at conception and from that moment forward life should be valued and protected. When elected, I will fight to uphold this moral value in the General Assembly. I am 100% pro-life. I am also against any form of euthanasia.

5. What is your position on taxes

Taxes have increased at an alarming rate in Maryland. In the 2013 session alone we saw an astronomical 86% increase on the Maryland gas tax and the implementation of a Rain

Tax. It is time for Maryland's elected officials to advocate for a pro-growth economy that focuses on bringing business back to Maryland while protecting the middle-class from high and unnecessary taxes. I will advocate for a lower corporate income tax and work with the other caucus members to implement a far-reaching tax relief package. Maryland's high taxation has put an unnecessary burden on our residents and slowed job creation. I will do everything in my power to fight for lower taxes.

6. What is your position on common core

I am against common core and believe we should remove it from Maryland schools. I believe the best education comes from localized control and parent choice.

7. How would you work to create jobs

I do not believe that the government should create jobs, but should move out of the way of business owners and the private sector so that they can create them. I would focus on removing many of the regulatory burdens and taxes that makes the cost of business in Maryland uncompetitive. Many of the environmental regulations have been the most hostile to job creation for the agricultural and fracking industries.

8. Please explain your position on Obamacare and healthcare in general

I believe in the full repeal of Obamacare, but also see a need for other changes in health care law. I believe that the most effective and important reforms that can be easily made are the introduction of tax-free health savings accounts and tort reform that limits the waste, fraud, and abuse that is very common in health care.

9. What is your stance on converting from a commissioner form of government to a county executive form of government

I prefer the commissioner form of government because it provides for stronger checks and balances than charter government does. Checks and balances are crucial in order to keep lower taxes and smaller government in Carroll County. A prime example would be the transfer tax debate from several years ago. The commissioners were in favor of the transfer tax, but due to a majority of the Carroll County Delegation opposing it, we were able to avoid the tax.

If the county were to move to charter government, the implementation of a tax cap would be more than necessary to prevent higher taxes.
